Exhibition Guidelines and Rules

- a) Entry limited to six (6) pieces per person of original artwork, which may be submitted by any person for approval by Gallery Director, space permitting and submission standard.
- b) Entry submission date: **Wednesday, August 24 - 25 at 4 p.m.**
- c) All artworks must be securely **framed** with **screw eyes inserted** and a cord or wire attached or mounted on form core with hanger attached. If not framed or mounted correctly, artwork will be rejected.
- d) Entries once accepted for the exhibition are NOT to be removed from the Gallery during the period of the show except when sold to a departing visitor. All works once hung are to remain as placed. Artists may not interfere with their work once it has been hung.

Processing ALL sales and will wrap sold artwork where necessary. Payment will be issued to the artist within 30 days of sale or payment by the purchaser. A sales spreadsheet will be provided to the Exhibitor at the end of the show.

- e). Reserves the right to move artwork being exhibited. All artwork will be handled in a professional manner as not to incur damage. Whilst the BSoA takes every care in handling the artwork, sometimes accidents do happen. If damage to the artwork is incurred, a reasonable and proportionate reduction of commission will occur in cases of professional negligence.
- f). Reserves the right to use the BSoA Galleries for functions at any time during exhibitions.
- g). The BSoA reserves the right to commission from any sales that are incurred beyond the exhibition for a period of six weeks after the closing date.
- h). The BSoA reserves the right to photograph and post any artwork on their website or Online Gallery for a period of ten weeks. This includes one week before the show opening, the show period and for the six weeks after the closing date.
- i) Entries must be brought to the Gallery by the time and date specified. All art pieces must be removed promptly on collection date. Items left beyond a week after closing of the exhibition subject to a **FINE of \$10 per week per item** after the first week. **BSoA is NOT liable for any damage to items left at the Gallery after this time.**

Pick-up deadline: 1p.m. Wednesday, September 20, 2021.

- j) The Bermuda Society of Arts (BSoA) receives a commission of **35%** on all sales.
